This form is to be completed only by those school authorities that want to have mozzarella cheese, processed American cheese and/or peanut butter diverted to processor(s) for them during school year 2006. In the space provided below, indicate the percentage of your school year 2006 share that you want diverted to any of the processors listed. You may choose more than one processor; however, the total percentage of each donated food you divert cannot exceed 100 percent.

The processors listed are those that have an agreement this school year. New agreements must be approved July 1 in order for these companies to participate for school year 2006. Only full truckloads may be diverted. Therefore, the volume of requests from school food authorities for each processor will determine the amounts, if any, to be diverted to each processor. If there is not enough requests to make up a full truckload, product will not be diverted and your allocation from the warehouse will not be reduced. If sufficient requests are received and donated food is diverted; your allocation from the warehouse will be reduced by the percentage you have diverted, each time it is ordered.

To estimate how much of each of the donated foods you can expect to receive next year, multiply your program's average daily participation by the pounds per child figure indicated. Then, indicate the percent of this amount that you want to have processed on the line next to the processor(s) you choose.

Please Note: The assessment fee charged by the Department of Education for finished processed products will be \$1.39 for school year 2006-2007.
