

In response to the need to provide good nutrition to children in needy areas, the Child and Adult Care Food Program (CACFP), established by Congress in 1968, provides reimbursement for meals served to children under 13 years of age enrolled in licensed family day care homes.



**Family Day Care Providers serving nutritious meals to children can get financial reimbursement for eligible children served.**

Family Day Care Providers interested in receiving Child and Adult Care Food Program benefits, or obtaining program information may contact any of the agencies listed. Many agencies provide services beyond the communities listed and throughout the state.

The Massachusetts Department of Elementary and Secondary Education has approved the Family Day Care, Child and Adult Care Food Program sponsors listed in this brochure.

CACFP sponsors receive Federal reimbursement to:

- inform providers of program benefits;
- provide training and technical assistance regarding proper nutrition, program duties and responsibilities;
- maintain program records;
- monitor providers; and
- distribute payments to providers in a timely fashion.

*Monitoring responsibilities include at least 2 unannounced visits to provider's homes annually.*
