EANS: An Introduction

CARES Act: The "first stimulus"

- Coronavirus Aid, Relief, and Economic Security Act (CARES) was signed into law on March 27, 2020
- ESSER-I included equitable services for non-public schools
 Much like they do for IDEA and ESSA (Title I, IIA, III, IV), districts offered equitable services to non-public schools
 - U.S. Department of Education changed ESSER-I equitable services guidance multiple times in 2020

CRRSA Act: The "second stimulus"

- Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act was signed into law on December 27, 2020
- Equitable participation of private schools does not appear in this law; instead, Congress created EANS
- Emergency Assistance to Non-Public Schools
 - \$24,225,048 million awarded to Governor Baker through Governor's Emergency Education Relief fund (GEER-II) on February 22, 2021
 - Per the law, Governor designates administration of program to the Department of Elementary and Secondary Education (DESE). DESE must run the program, taking \$200,000 for administration.
 - \$24,025,048 for non-public schools (assistance, services, reimbursements)

Eligibility

- Non-public schools are eligible if:
 - a) A non-public elementary or secondary school in Massachusetts
 - b) Approved to operate as a non-public school under Massachusetts General Law
 - c) A non-profit entity
 - d) Is currently operating and was in existence and operating prior to March 13, 2020
 - e) They have not participated, and will not participate, in the <u>second</u> federal Paycheck Protection Program (on or <u>after</u> December 27, 2020). Those who participated in PPP before December 27, 2020 are still eligible.



Targeting and Prioritization

 The EANS program must prioritize services or assistance to nonpublic schools that:

o enroll low-income students, and

o are most impacted by the qualifying emergency

Important: EANS is not a "grant" program

- EANS is structured as a program whereby DESE:
 - 1. Offers cash reimbursements to non-public schools for certain allowable expenditures and obtains title to anything that has a title (public control).
 - 2. Provides services and assistance for certain allowable expenditures to non-public schools.

1. Cash reimbursements

- DESE can reimburse non-public schools for allowable expenditures
 - a) Offers cash reimbursements (both past and future) to non-public schools and obtains title to anything that has a title; and/or
 - b) Non-public schools choose among allowable and reasonable expenditures (previously provided back to March 13, 2020, or to-be-provided at a later date) and choose vendors that provide the service. Once purchases are complete, then the state can reimburse.
 - c) Can't reimburse non-public schools for anything that was paid for previously with federal funds (i.e. GEER-I or PPP).



2. DESE as Provider of Services and Assistance

- DESE can provide services and assistance to non-public schools
 - a) DESE would need to be the purchaser of services
 - b) Non-public schools would be bound by available state-approved vendors (i.e. taken from existing state contracts), or additionally procured via open and competitive bids.

O2 Allowable Uses

Allowable Uses

The law spells out the following uses:

- A. supplies to sanitize, disinfect, and clean school facilities;
- B. personal protective equipment;
- C. improving ventilation systems, including windows or portable air purification systems to ensure healthy air in the non-public school;
- D. training and professional development for staff on sanitation, the use of personal protective equipment, and minimizing the spread of infectious diseases;
- E. physical barriers to facilitate social distancing

Allowable Uses, continued

- F. other materials, supplies, or equipment to implement public health protocols, including guidelines and recommendations from the Centers for Disease Control and Prevention for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff during the qualifying emergency;
- G. expanding capacity to administer coronavirus testing to effectively monitor and suppress coronavirus, to conduct surveillance and contact tracing activities, and to support other activities related to coronavirus testing for students, teachers, and staff at the non-public school;
- H. educational technology (including hardware, software, connectivity, assistive technology, and adaptive equipment) to assist students, educators, and other staff with remote or hybrid learning;



Allowable Uses, continued

- I. redeveloping instructional plans, including curriculum development, for remote learning, hybrid learning, or to address learning loss;
- J. leasing of sites or spaces to ensure safe social distancing to implement public health protocols, including guidelines and recommendations from the Centers for Disease Control and Prevention;
- K. reasonable transportation costs;
- L. initiating and maintaining education and support services or assistance for remote learning, hybrid learning, or to address learning loss

Per the law, certain services/assistance are not reimbursable

Before you begin

• Before you begin the application, **make sure**:

- That the school's contact information in <u>DESE's directory administration system</u> is up-to-date (if not, email the correct information to <u>ESEDirectoryAdministrator@mass.gov</u>).
- That the school has accurately completed the annual DESE data collection for non-public schools: the Individual Non-Public School Report. If not, interested non-public schools must complete the data collection before submitting this application. Questions about the data collection (accessing the online portal, etc.) may be sent to <u>privateschools@mass.gov</u>.
 - N.B.: For approved and unapproved private special education schools, public student information is collected through SIMS, and therefore completion of the Individual Non-Public School Report is not required.


