Subject: Notice of FY 2024 ESSA (Titles I, IIA, and IVA) program monitoring required actions

Thank you for submitting materials for your district's FY 2024 federal grant program monitoring review. Our federal grants program staff members have reviewed the materials your district submitted and, in certain cases, have requested and obtained additional documentation from your district.

All district submissions, record of review, and the district's monitoring outcomes report are located in the Communication Hub and Monitoring Portal (CHAMP). The report lists all review criteria and indicates which requirements were fulfilled and which had findings. Criteria with findings include a description of the finding, required action, and a deadline for submission of evidence that the required action to address the finding is complete.

Evidence of required actions must be uploaded in CHAMP by **October 10, 2025** in the same manner that initial submission of documentation was uploaded by the district's monitoring contact person.

The federal government, the Department (DESE), and the district all have an interest in seeing that actions taken to address findings are sufficient and that compliance with grant program requirements is sustained beyond completion of this monitoring review. To this end, your ESSA grant monitoring reviewer will be in contact as needed to provide your district support. Finding

Requirements

Equitable Access to Excellent Educators: The district works to identify and address any disparities that result in historically disadvantaged student groups being taught at higher rates than other students by lower rated, inexperienced, or out-of-field teachers.

Legal Standards

ESEA § 1111(g)(1)(B)

Finding Description

This may include: Completed templates provided by DESE on developing strategies or monitoring progress; written project plan, timeline, theory of action, and/or goals; description of new practices/policies in response to data. - Incorporate data that the district is using to inform strategies to address equity gaps. This could include: Documentation of district data analysis based on the Student Learning Experience (SLE) report in Edwin Analytics; completed templates provided by DESE on using data beyond the SLE Report or engaging stakeholders in root cause analysis.

8-A Title IIA Allocating Funds

Finding

Requirements

Allocating funds: Activities supported with Title II, Part A funds must collectively address the needs of all subgroups of students in the district. In addition, schools identified for support and improvement, and schools with the highest percentage of low-income students are prioritized for participation in activities funded by Title II, Part A.

Legal Standards

ESEA § 2103(b)(2) and § 2103(b)(2)(C)

Finding Description

District's allocation of funds description did not clearly explain how they prioritize the distribution of Title IIA funds to schools.

Required Action

Submit copy of written policy for distributing Title IIA funds that aligns with the statutory requirements to “schools with the greatest needs, have the highest percentages or numbers of children in poverty, or are identified for support and improvement.”

Deadline for Submission of Evidence

Oct 10, 2025

12-A Title IVA Distribution of Funds

Finding

Requirements

Districts are required to prioritize the distribution of Title IVA funds to schools with the greatest needs, have the highest percentages or numbers of children in poverty, are identified for support and improvement, are implementing targeted support and improvement plans, or are identified as a persistently dangerous public elementary school or secondary school under section 8532.

Legal Standards

ESEA §4106(e)(2)(A)

Finding Description

District's allocation of funds description did not clearly explain how they prioritize the distribution of Title IVA funds to schools.

Required Action

Submit copy of written policy for distributing Title IVA funds that aligns with the statutory requirements to “schools with the greatest needs, have the highest percentages or numbers of children in poverty, or are identified for support and improvement.”

Deadline for Submission of Evidence

Oct 10, 2025

13-A Title IVA Program Activities Evaluation**Finding****Requirements**

The district annually reports to the state how funds are being used and the degree to which the district has made progress toward meeting the objectives and outcomes described in its application for the use of these funds.

Legal Standards

ESEA §4106(e)(2)(F)

Finding Description

District's evaluation summary does not include analysis of data used to evaluate impact of all Title IVA funded activities in both district schools and participating private schools.

Required Action

Submit a written summary of the 2024-25 school year Title IVA program evaluation, including indicators of impact on student achievement, strengths and weaknesses of the program, and subsequent program changes. The summary should include evaluation of participating private school services as well. Submit a detailed plan for how you will carry out the 2025-26 Title IVA program evaluation, including the timeline of steps involved, data collected and analyzed to gauge impact, individuals responsible for each step, and stakeholders consulted. Include in your plan how you will collaborate with participating private schools to evaluate services. This plan can be made using this document:
