Dear Friends:

I am pleased to issue our annual report, *Student Exclusions in Massachusetts Public Schools: 1999-00*. This report provides information regarding student exclusions, defined as the removal of a student from school for disciplinary reasons for more than ten consecutive school days, including permanent or indefinite removals. This information will be useful to the legislature, the Governor, and the Board of Education as they continue to address the issues of student discipline and school safety.

The Education Reform Act of 1993 and subsequent amendments authorize school principals, rather than school committees, to expel students who carry weapons or illegal drugs to school, assault school personnel, or are convicted of a felony while off school grounds. Districts are not required to provide excluded students with alternative education, with the exception of special education students who, under federal law, are entitled to receive alternative education if removed from school for ten days or more.

Summary of Key Findings

In the 1999-00 school year, there were 1,412 student exclusions, an increase of six percent from the 1,326 exclusions in the prior year. Although the total number of exclusions in 1999-00 had increased from the previous two years, it was six percent lower than school year 1996-97, which had 1,498 student exclusions.

In comparison to the total student enrollment, a disproportionate number of students excluded from school were African American and Hispanic. Twenty percent of all exclusions involved a student with a weapon on school premises, a decrease of four percentage points from the previous year. Seventy percent of all students who were excluded from school were provided with alternative education, an increase of five percentage points from the 1998-99 school year.

Exclusion rates varied among school districts. Of the 371 school districts in 1999-00, 137 districts, or 37 percent, excluded students from school. Of these 137 districts reporting student exclusions, 96 percent reported fewer than ten exclusions and the remaining four percent, or 16 districts, reported ten or more student exclusions. This is a decrease from the prior year when 23 districts reported ten or more student exclusions.


We appreciate the efforts that school districts are making to ensure safe and orderly school environments and to provide serious learning opportunities for all students. Safe learning surroundings at school are

essential to an effective education. Many districts do an outstanding job in providing most or all of the students they exclude with an alternative education. This is a very important goal statewide, and school districts must continue to make safe, effective schools a top priority.

Background

The 1999-00 school year was the seventh year in which the Department of Education required schools to submit student-level data on student exclusions. The following analyses are based upon data reported by schools on students excluded, as defined at the right, between July 1, 1999, and June 30, 2000.

A student exclusion is defined as the removal of a student from participation in regular school activities for disciplinary purposes for more than ten consecutive school days. The removal could also be permanent or indefinite.

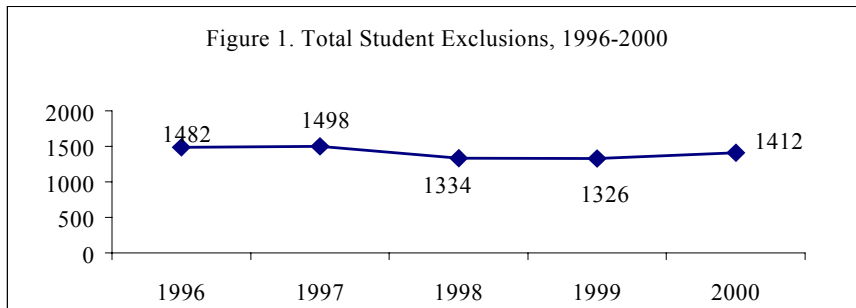
Results

There were 1,412 student exclusions in the 1999-00 school year from 137 school districts and charter schools. A total of 1,378 students were excluded, of whom 31 were excluded two or more times during the year. The greatest number of exclusions for an individual student was three.

As shown in Figure 1, the number of student exclusions during the 1999-00 school year increased by about six percent from the previous two years, but is six percent less than from three years ago, when the largest number of exclusions (1,498) was reported. The number of students excluded more than once during the 1999-00 school year increased by 19 percent



from the previous year and by seven percent from 1997-98. More than two-thirds of the students excluded from school were provided with alternative education, an increase of five percentage points from the prior year.

Exclusions by Student Characteristics

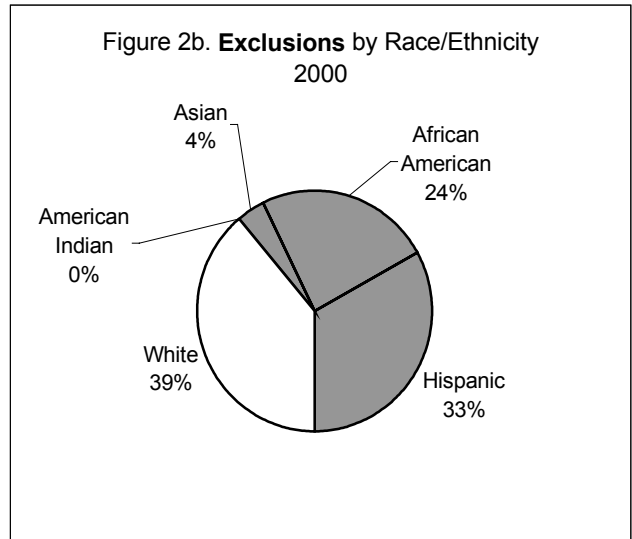
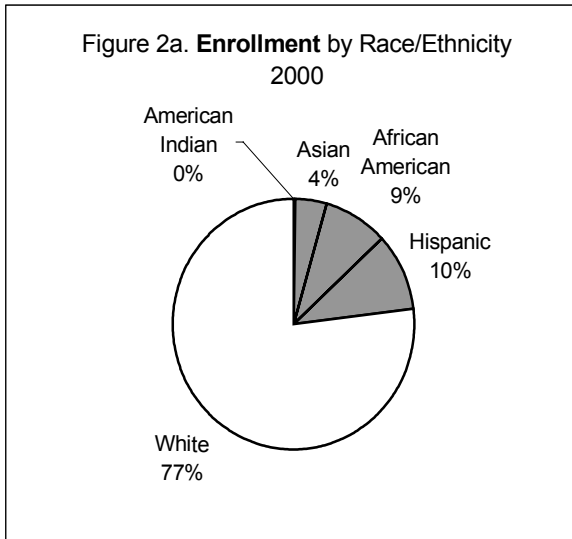
As shown in Table 2, over 80 percent of excluded students were male. The proportion of male exclusions in 1999-00 decreased slightly from the previous year. In comparison to the total student enrollment for 1999-00, a disproportionate number of students excluded from school continue to be students of color. This pattern has been consistent over time.

As shown in Figures 2a and 2b, while students of racial and ethnic minority groups represented 23 percent of the total student enrollment, they accounted for 61 percent of student exclusions. Specifically, Hispanic students, almost one-tenth of the total student enrollment, accounted for one-third of student exclusions. African American students, nine percent of the total student enrollment, accounted for 24 percent of student exclusions. Although white students comprised 77 percent of the total student enrollment, they accounted for 39 percent of student exclusions.



Students who were excluded ranged in age from six to 21-years-old. Female students who were excluded ranged in age from ten to 20-years-old and male students ranged in age from six to 21-years-old. Consistent with last year's data, two percent of exclusion cases involved students age 10 or younger, and 22 percent involved students between the ages of 11 and 13. More than half of student exclusions (56 percent) were among students 14 to 16-years-old, a figure that has remained fairly constant over the past four years, while 20 percent of students excluded were between the ages of 17 and 19. Only three exclusions involved students 20 years of age or older.

Regular education students, who comprised 83 percent of the total student enrollment, accounted for 73 percent of student exclusions. Special education students, who comprised 17 percent of the total enrollment, accounted for 27 percent of exclusions. The proportion of special education students among student exclusions increased by two percentage points from the 1998-99 school year.

Exclusion Rates

As illustrated in Table 3, the exclusion rates, which represent instances of exclusion per 1000 students enrolled, showed male students continue to be excluded at a higher rate than female students. Approximately one in every 500 male students was excluded compared to one in every 2,000 female students. There were significant differences in the exclusion rates among the various racial/ethnic groups as well. The exclusion rates for African American students, 4.1, and Hispanic students, 4.7, were significantly higher than rates for Asian (1.2), Native American (1.2) and white students (0.7) in the 1999-00 school year.

Over the past three years, exclusion rates for all racial groups have fluctuated. African American students accounted for the most significant rate change from 3.1 to 4.1 exclusions per 1000 students from 1999 to 2000.

As shown in Table 4, exclusion rates increased with the grade levels up to ninth grade where they peaked, and then decreased in the grades following ninth.

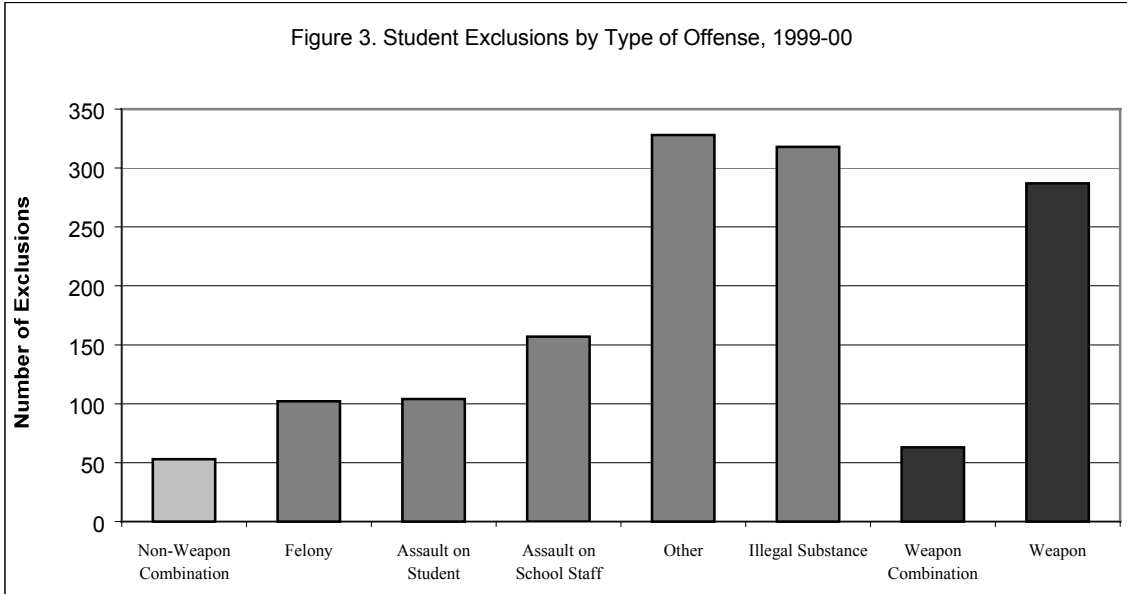

Exclusions by Type of Offense

Schools reported one or more offenses for each student exclusion. Figure 3 illustrates the number of exclusions that occurred for each of the offenses specified in state law as actions for which school principals are authorized to exclude students and for “other” offenses. Exclusions resulting from more than one offense are displayed as either a “weapon combination” or a “non-weapon combination.”



As shown in Table 5, over one-fifth of exclusions were for possession of an illegal substance, a slight increase from the previous year. Approximately 11 percent of exclusions were for assaults on school staff, a slight decrease from the previous year, and seven percent of exclusions were for assaults on students, a decrease from the two previous years. Seven percent of student exclusions were for a felony committed outside of school, unchanged from the previous year. Exclusions for an offense reported as “other” accounted for 23 percent of the student exclusions, an increase of seven percentage points from the previous year.

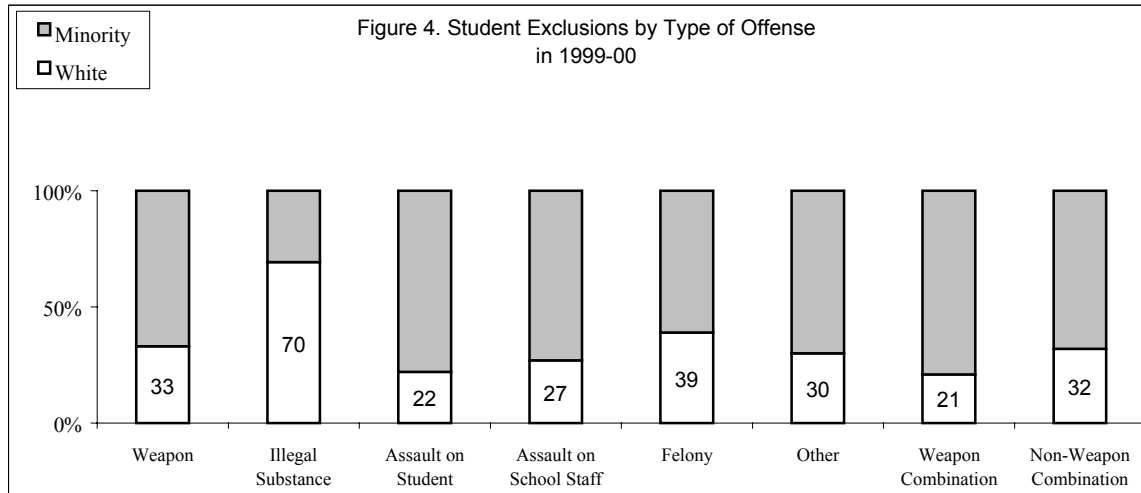

Exclusions due to weapons on school premises have fluctuated over the past three years. In the school year 1999-00, 24 percent of student exclusions involved weapons on school premises, a decrease of five percentage points from the previous year. Of the 350 exclusions that involved a weapon, 75 percent involved a knife, an increase of seven percentage points from the prior year. Three percent involved a gun, a decrease of five percentage points from the previous year, and two percent involved an explosive or incendiary device, virtually unchanged from the previous year. Those offenses reported in the “other” type of weapon category accounted for 17 percent of student exclusions involving a weapon, a decrease from the previous year by three percentage points. The “other” types of weapons categories most often reported were razor blades or box cutters, scissors, various tools, and bats and clubs.

Figure 4 compares the distribution of exclusions for each type of offense for racial/ethnic minority students and for white students. Minority students accounted for 67 to 79 percent of exclusions for weapons violations and 73 to 78 percent for assaults on staff and/or students, while white students accounted for 70 percent of exclusions for possession of illegal substances.



Exclusions by Length of Time

Schools were asked to report the date the student was excluded and either the date the student returned to school or was eligible to return to school, if the exclusion was not permanent. In 1999, the Department began collecting data specifically on the number of *school days* a student missed due to exclusion from school. Previous reports included analyses of exclusions by calendar days, which are not comparable to the number of school days.

In 1999-00, 13 percent of student exclusions occurred for 11 to 20 school days, slightly more than one-third (38 percent) were for 21 to 40 days and 27 percent were for 41 to 179 days as shown in Table 6. Eleven percent of student exclusions occurred for one school year (180 school days). Approximately 10 percent were permanent exclusions, commonly referred to as expulsions. Although the overall number of student exclusions had increased by six percent from the previous year, the number of students permanently excluded in 1999-00 (145 students) decreased by four percent from the 180 students reported permanently excluded in 1998-99 (Table 6).

Table 7 shows that 17 percent of the white students who were excluded from school were removed permanently, compared to eight percent of Asian-American students, five percent of Hispanic students and eight percent of African-American students. No American Indian students were excluded permanently. African-American and Hispanic students had their highest percentage of students excluded for 21 to 40 school days; American Indian, Asian, and white students had their highest percentage of students excluded for 41 to 179 days.

Alternative Education

As shown in Table 8, 70 percent of all students excluded from school in 1999-00 were provided with alternative education, an increase of five percentage points from the previous year. Sixty-one percent of regular education students excluded from school received alternative education, an increase of five percentage points from the prior year. Federal law requires special education students who are excluded from school to be offered alternative education. Ninety-five percent of the special education students excluded in 1999-00

received alternative education, while five percent did not. This five percent is a decrease of three percentage points from the previous year. Of the 19 special education students who did not receive alternative education, nine were reported as having refused or as not responding to the offer of alternative education, four were reported as having been incarcerated, five had moved, and for one student the school chose not to provide it.

Table 9 illustrates that of the 987 exclusions in which students were provided with alternative education, 65 percent attended an in-district alternative program, 19 percent were provided with home tutoring, and 12 percent received alternative education in a private setting. The remaining two programs, work/community service and an alternative program in another district, accounted for the remaining four percent of student exclusions.

In 68 percent of the 425 exclusion cases where alternative education was not provided, the schools chose not to provide it. This was an increase of eight percentage points from the prior year, and a decline of two percentage points from the 1997-98 school year. For nearly one-fourth of all exclusions, the schools reported that students refused to accept or did not respond to offers of alternative education, a decrease of six percentage points from the previous year. For the remaining nine percent of exclusions, students had moved or were incarcerated. The number of excluded students who were incarcerated had decreased from the previous year (Table 9).

The provision of alternative education varied by the length of the exclusion and student classification (Table 10). Eighty-three percent of regular education students who were excluded from school for one year were provided with alternative education. Almost 56 percent of regular education students who were excluded for 41 to 179 days received alternative education, nearly 79 percent who were excluded 21 to 40 days received alternative education and about 36 percent who were excluded for 11 to 20 days received alternative education. Five percent of the regular education students who were excluded permanently received alternative education. For all intervals of exclusions, except permanent, a much greater percentage of special education students received alternative education due to federal mandates that require these students to have this educational option.

Exclusions by District

As shown in Table 11, over half of the 371 school districts reported no student exclusions for the 1999-00 school year. A total of 137 districts, or 37 percent, excluded students from school. One-quarter of the school districts reported between one and three exclusions. Nine percent of the school districts reported between four and nine student exclusions, and four percent, or 16 districts, reported ten or more student exclusions. This is a decrease from the prior year when 23 districts reported ten or more student exclusions.

The number of districts having ten or more student exclusions as shown in Table 12 has decreased from the previous year. The first seven districts are the same as last year, and each one except for Holyoke reported an increase in the number of students excluded during the 1999-00 school year. More than two-thirds of the districts in 1999-00 provided alternative education to 50 percent or more of their students.

Although some districts may have excluded more than ten students from school, due to their large total enrollment, they had fewer than four exclusions per 1000 students enrolled in the district. Other districts had fewer than ten student exclusions, but had four or more exclusions per 1000 students because they had smaller total enrollments. As illustrated in Table 13, there were 17 districts reporting four or more student exclusions per 1000 students in 1999-00 compared to 23 districts in 1998-99.

Student Exclusions by District
